

# Call for Nominations Marthe Vogt Award 2023

# 1. Objective

The Marthe Vogt Award of the Forschungsverbund Berlin is intended to recognize outstanding achievements by young female scientists. With this award, the Forschungsverbund Berlin would like to help provide new impulses for research activities and enhance the number of excellent female scientists in the fields of science and research.

# 2. Content

The Marthe Vogt Award honors an outstanding doctoral thesis in a field of research covered by one of the institutes of the Forschungsverbund Berlin.

The institutes' fields of research include, among others, information and communication technologies, structural research, optoelectronics and laser research, microsystems technology, new materials, applied mathematics, molecular medicine and biology, veterinary medicine, biotechnology, and environmental research.

The doctoral thesis need not be obtained at one of the institutes of the Forschungsverbund Berlin (see Point 4).

## 3. Endowment

The award is granted annually and consists of a certificate and a prize money of 3,000 euros. In the case of equally outstanding theses, the award can be granted to several awardees.

## 4. Requirements for nominees

The award is assigned to young female scientists. As a general rule, no more than 6 years should have elapsed between their degree and doctorate. The doctorate should have been completed with distinction (summa cum laude or the best possible rating based on the respective doctoral degree regulations) after 31 May 2021 at a non-university research institution or at a university in the Berlin / Brandenburg region.

The doctoral thesis or parts thereof should have been published in renowned scientific journals.

## 5. Submission of nominations

Nominations can be made by directors of non-university scientific institutions as well as habilitated faculty members of universities in the Berlin / Brandenburg region.

The nominations shall include the following documents (in English or German):

- a copy of the doctoral thesis;
- the nominee's curriculum vitae;
- a summary on no more than three pages (including figures) of the most important findings of the doctoral thesis, representing its significance;
- a report by the nominator on the doctoral thesis and the nominee;
- master's degree / diploma certificate and doctoral degree certificate.

## 6. Privacy notices

- Nominees give their written consent to their data being passed on by the nominator for the purpose of participating in the Marthe Vogt Award competition.
- Nominees' documents will be used and stored exclusively within the FVB as part of the award procedure.
- All documents submitted by nominees who have not been granted the award will be deleted 30 days after the award ceremony at the latest.
- The rights of the data subjects, as currently specified in Section VIII of the FVB's privacy policy (https://www.fv-berlin.de/en/privacy-statement), also apply without restriction to the data collected in connection with the Marthe Vogt Award.

## 7. Practical advice

The award is granted by a committee consisting of members of the FVB Executive Board. There is no claim for awarding. The committee's decision is final.

The presentation of the award will take place in a public event on November 8, 2023.
